I HOPE I'M NOT BOTHERING YOU, BUT I DON'T KNOW WHAT ELSE TO DO. THE INDITEMENT DOESN'T HAVE ANY VIOLENCE IN IT, I HAVE TIES TO THE DETROIT COMMUNITY, THE GOVERNMENT HAS PLENTY OF NEW TECHNOLOGY LIKE G.P.S TO KEEP UP WITH ME, I WOULD EVEN TAKE "HOME CONFINEMENT" YOUR HONOR, ALL I AM ASKING YOU FOR IS A "CHANCE" TO BE WITH MY FAMILY IN CASE I HAVE TO GO TO PRISON FOR THE FIRST TIME IN MY LIFE. I AM 39 YRS OLD AND MY PARENTS ARE 59 YRS OLD SO PLEASE PLEASE HELP ME!

P.S A QUICK NOTE, I THINK ALMOST EVERYONE ON THE INDITEMENT HAS HAD A BOND YOUR HONOR AND TIME WITH THEIR FAMILY AND LOVE ONES, I AM BY NO MEANS A THREAT, I HAVE A MOTHER, FATHER, DAUGHTERS, SISTER, NIECES & NEPHEWS IN THE COMMUNITY NONE OF US HAVE EVER BEEN TO PRISON, I WAS RAISED IN THE CHURCH SO MY FAITH IS STRONG IN GOD, I AM PRAYING TO GOD TO WORK THREW YOU TO ALLOW ME SOME TIME WITH MY FAMILY AFTER BEING IN JAIL AWAITING TRIAL FOR 22 MONTHS. ONCE AGAIN THANK YOU SO MUCH FOR YOUR VALUABLE TIME
